NOTIFICATION

In exercise of powers conferred under section 18 of the Energy Conservation Act, 2001 (52 of 2001), the Governor of Arunachal Pradesh is pleased to issue the following directions for efficient use of Energy and its Conservation in the State of Arunachal Pradesh.

1. Mandatory use of energy efficient lighting systems in Government Buildings/ Govt. aided institutions, bodies, Boards, Corporations etc.

- (i) The use of incandescent lamps and 40 watt conventional tube lights with ballast choke in all new buildings/ institutions constructed under Govt. sector and Govt. aided institutions , bodies, Boards, Corporations etc is banned with immediate effect. It will be mandatory to use energy efficient lighting systems like Compact Fluorescent Lamps (CFL) or T-5, 28 watt tube lights or LED Lamps or LED tube lights.
- (ii) It will also be mandatory that in the existing buildings the defective incandescent lamps and 40 watt conventional tube lights when replaced would be replaced by Compact Fluorescent Lamps (CFL) or by T-5, 28 watt tube lights or by LED Lamps or LED tube lights.

2. Mandatory use of Star Labelled room air conditioners and frost free refrigerators in Govt. Buildings/ Govt. aided institutions and bodies, Boards, Corporations etc.

- (i) The use of room air conditioners (both split and window type) and frost free refrigerators below 4 (four) Star Label in all new buildings and institutions under Govt. sector and Govt. aided bodies, institutions, Boards, Corporations etc is banned with immediate effect. It will be mandatory to use at least 4(four) Star labelled room air conditioners and frost free refrigerators.
- (ii) It will also be mandatory that in the existing buildings the defective room air conditioners (split and window type) and frost free refrigerators whenever replaced will be replaced by at least 4 (four) Star labelled room air conditioners and frost free refrigerators.
